 - 1. Pavilion Update Will be out for bid for 30 days. Selection processes is 10 to 15 days. Then to county council for approval. Contractor will have 45 days to complete. No plans to begin before October 10; avoid conflict with Community Day/guests
 - Sangaree Park baseball field improvements planning and bids on going. Received one bid to date.
 - 3. Street sign replacement continues Tabby Creek and Highland Village are next.
 - 4. Neighborhood entrances sign painting: Victoria Place is done. It was a major project, with removal of the rotted lattice and posts. Hampton Trace is next.
 - 5. Community day scheduled for October 8 is in full swing.
 - 6. Lyon's Cove Park PARD Grant equipment is due to arrive this month

- A. Basketball Court
 - 1. Basketball court is very popular and been used; benches have been installed
- B. Baseball Field
 - Bids are coming slowly for fence work 2 have been received; 1 for parts and labor and one for labor only
 - 2. Available green spaces at field are being utilized by many for a variety of activities
- C. Walking Trail/Nature Trail
 - 1. Needs to be graded again
 - 2. Two benches are planned for the area
 - 3. Walking bridge is planned
- D. Pavilion
 - 1. Pavilion size is 24' x 60'
 - 2. County representatives visited, met with Tim King for an overview of the project
 - 3. Stakes marking the area were placed
 - 4. **Invitation for Bids** is going out from Berkeley County very soon. https://proposals.berkeleycountysc.gov/index.php
 - 5. Feedback regarding having a pavilion has positive feedback from senior residents
 - 6. Restrooms are being discussed for installation at a date to be determined in the future
 - 7. A variety of possible uses for the pavilion were mentioned, one being partnering with the BCLS Sangaree Library for a community movie night.
- E. Parkway Beautification
 - 1. Entrances have flowers
 - 2. Landscaping Specialist position was filled.
 - 3. Fall flowers are being planned and will be ordered this week of 8/8
 - 4. Entrance signs are still be repaired and painted as the project continues
 - 5. Sangaree signs have been reinstalled at the parkway entrance at Royle Road
 - 6. Farmington Road/Berkeley Drive repairs post-accident are in the hands of Berkeley County and the driver's insurance company

IV. New Business

- A. Berkeley County Sheriff's Office Capt. Dan Wilson
 - 1. Capt. Wilson is commander over the deputies on the south end of the county
 - 2. Oversees the BCSO Sangaree Substation
 - 3. Working with citizens is #1 for him.
 - 4. BCSO is currently down 30 deputies
 - 5. Deputies are supporting needs with the jail (also short-handed)
 - 6. Deputies are SROs in the public schools within Berkeley County
 - 7. Calls have increased in Cane Bay & Nexton

 - a. Possible extra lighting is coming; working with BEC; will let SSTD know
